

Below are 2 bills which I would like to submit to Congress if I win the house race for District 7. If I don't, I would ask the District 7 Representative who wins in November 2024 to submit them.

The first "Congressional Term Limits Act" is intended to ensure that elected representatives in the United States Congress serve the best interests of the people they represent, rather than focusing on their own re-election. By imposing term limits, we aim to foster a more dynamic and responsive legislative body that better reflects the will of the American people. Proposed Term Limits for Congress, 1 term (6 years) for Senators and 2 terms (4 years) for House of Representatives. Preventing politicians from getting too entrenched likely will result in legislation that betters the country for all Americans.

The second "Congressional Integrity Affidavit Act, " is intended to ensure that elected representatives in the United States Congress serve the best interests of the people they represent, rather than focusing on their own re-election.

***Title:** Congressional Term Limits Act**

****Preamble:****

Be it enacted by the Congress assembled, that in order to promote fair representation and prevent the entrenchment of power, the following term limits shall be established for members of the United States Congress.

****Section 1: House of Representatives Term Limit****

- Members of the House of Representatives shall be limited to serving a maximum of two terms in office.

****Section 2: Senate Term Limit****

- Members of the Senate shall be limited to serving a maximum of one term in office.

****Section 3: Implementation****

- This bill shall take effect immediately upon passage.

****Section 4: Enforcement****

- Attempt of any member of Congress to attempt to run for office which violates the term limits set forth in this Act shall be ineligible to run for re-election.

****Section 5: Severability****

- If any provision of this Act is found to be unconstitutional, the remaining provisions shall remain in effect.

****Section 6: Funding****

- Necessary funds for the implementation and enforcement of this Act shall be allocated from the existing budget of the United States Congress.

****Section 7: Sunset Provision****

- This Act shall be in effect for a period of 20 years, after which Congress may review and decide whether to extend, modify, or repeal the term limits established herein.

Bill 2 – Reducing Impact of Special Interest Groups

****Title:** Congressional Integrity Affidavit Act**

****Preamble:****

Be it enacted by the Congress assembled, that in order to uphold the integrity of the legislative process and ensure that decisions are made in the best interest of the country, the following requirements shall be established for members of the United States Congress.

****Section 1: Affidavit Requirement****

- Following the passage of any bill or resolution in the United States Congress, each member of Congress who voted in favor of the legislation shall be required to sign an affidavit stating that their vote was made in the best interest of the country and not influenced by any special interest group that supported them financially.

****Section 2: Content of Affidavit****

- The affidavit shall include a statement affirming that the member of Congress considered the merits of the bill, its potential impact on the country as a whole, and the views of their constituents in making their decision.

****Section 3: Public Disclosure****

- The signed affidavits shall be made publicly available on the official website of the United States Congress within 30 days of the bill's passage.

****Section 4: Enforcement****

- Failure to sign the required affidavit within the specified timeframe shall result in a formal investigation by the Congressional Ethics Committee.

****Section 5: Penalties****

- Any member of Congress found to have provided false information in their affidavit or to have violated the provisions of this Act shall be subject to disciplinary action, including censure or expulsion from Congress.

****Section 6: Implementation****

- This bill shall take effect immediately upon passage.

****Section 7: Severability****

- If any provision of this Act is found to be unconstitutional, the remaining provisions shall remain in effect.
